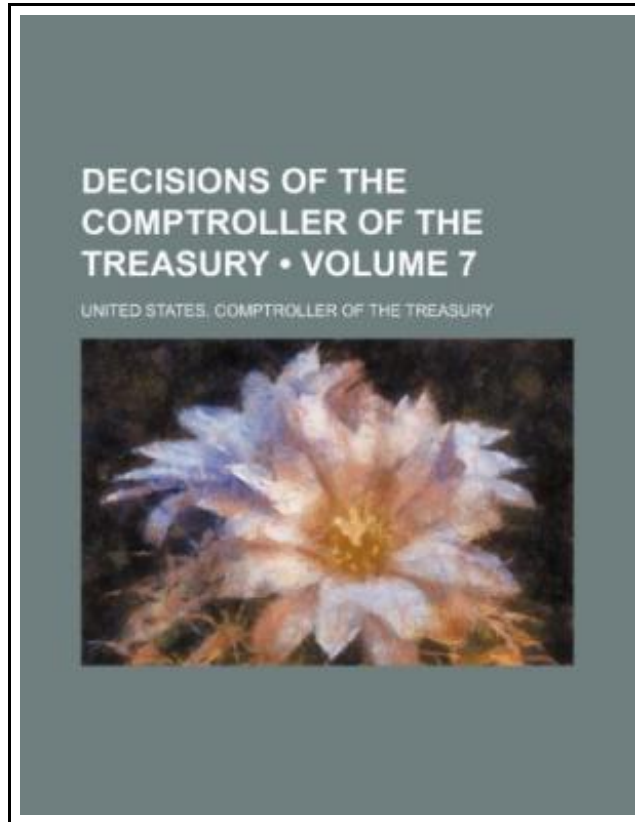

He was entitled to mileage upon this order just as he would have been on any other order, without regard to the fact that it might have been issued as a preliminary step to his final discharge. And the only question to be determined is, What journey did the Department mean to require him to perform Upon all the evidence it is concluded that his home at the date of the order under which he traveled was in Hoboken, N. J. The action of the Auditor in charging against him the amount theretofore received as mileage will be reversed, and the amount allowed as mileage from Mare Island to San Francisco, Cal. , will be disallowed. The Auditor allowed only waiting-orders pay from date of detachment, December 3, 1898, to date of discharge, December 17, 1898, a period of fourteen days. From this time should be deducted six days allowed for travel to Hoboken, N. J. , and for which other duty pay should be allowed. For the remainder of said time he is entitled only to waiting-orders pay, as allowed by the Auditor. The Auditor allowed two months extra pay, under the act of March 3, 1899 (30 Stat. , 1228), as for service outside the United States, at waiting-orders rates, instead of one months extra pay, as for service within the United States, upon the following report of the Bureau...
